

7 | Inspection / Service

According to DIN EN 806-5, backwash filters must be inspected / serviced every six months and at the same time the user has to perform a backwash as well. Furthermore, the filter must be checked for tightness. Defective components must be replaced by trained specialists.

Backwash




Fig. 4: Backwash unit

If the water pressure in the pipe system drops due to an increasing pollution of the filter element, a backwash must be performed; a backwash definitely must be performed every six months at the latest. In order to do so, the backwash handle (refer to fig. 4) must be turned in the direction of the arrow until the stop position is reached. Keep the backwash handle in this position for approx. 5 - 10 sec. Afterwards, turn the handle back. In case of persistent impurities, perform several backwash processes.

Although these parts are wearing parts we grant a limited warranty of 6 months.





Pressure loss curve of KICKER®




Backwash water volume

General information

Our systems must be installed by an approved sanitary and heating company.

Check the components for transport damage.

Protect the systems from frost and do not install them near heat sources with high radiation temperatures.



Attention: Do not clean the filter with cleaning agents that contain alcohol or solvents!

In case of drinking water that contains coarse dirt, a coarse filter has to be installed upstream of the system.

1 | Application

The KICKER® filters are designed for the filtration of drinking water. The filters are not suitable for circulation water that has been treated with chemicals. Furthermore, they are neither suited for oils, greases, solvents, soaps and other lubricating media, nor for the separation of water-soluble substances. The filters are suitable for the pressure range and negative pressure range. A backwash process is only possible when used in the pressure range.

3 | Installation preconditions




Fig. 1: Drain connection

4 | Scope of delivery

Please observe local installation directives and general regulations

The installation site must ensure the protection of the filter against chemicals, dyes, solvents, vapours and direct sunlight. Observe the flow direction (→ indicated on the housing), install stress-free. The installation site must be frost-proof.

The filter should be installed in pipes of equal dimensions as the connection diameter of the filter.

We recommend a direct drain connection. The backwash water must be discharged without backflow (refer to fig. 1).

5 | Installation




Fig. 2: Installation drawing, front view of KICKER®

According to DIN EN 806-2 and DIN 1988-200, the KICKER® filter must be installed in the cold water pipe downstream of the water meter and upstream of the distribution pipes resp. the devices to be protected. Shut-off valves need to be installed upstream and downstream of the filter (refer to fig. 2). The filter is only suited for horizontal installation.

6 | Start-up

Upon installation, start up the filter by opening the shut-off valves. Afterwards, the pipe must be ventilated via the nearest connection. Perform a backwash process (refer to item 7 inspection / service).

Check for tightness

After installation as well as after each service, the filter must be checked for tightness. To do so, the highest possible occurring operating pressure must be applied and the filter must visually be checked for leakages.
